## **Privacy Policy**

#### Rationale

This policy sets out how the New Zealand Dental Association, Canterbury Branch (NZDA Canterbury) handles personal information collected on Members and how NZDA Canterbury implements the requirements of the Privacy Act 2020.

This policy does not limit or exclude any rights under the Privacy Act.

#### **Definitions**

Term	Definition
Privacy	Refers to the control of how NZDA Canterbury uses personal information.
Personal Information	Information about identifiable living people.
Privacy Breach	Includes unauthorised or accidental access to personal information, or disclosure, alteration, loss or destruction of personal information.
Notifiable Breach	Where it is reasonable to believe that the breach has caused or is likely to cause serious harm to an affected individual.

### **Purpose**

The purpose of this policy is to ensure:

- Information gathered about NZDA Canterbury Members is lawful and is kept confidential
- Accurate and up to date information gathered is collected from the person concerned and is relevant to the successful running of NZDA Canterbury
- All information is stored and disposed of securely and protected from unauthorised use or disclosure
- A Privacy Officer/s is appointed who ensures Members are informed of the Privacy Policy and procedures, and the purposes for which information is collected. This role will be held by the Branch President, unless explicitly delegated to another Executive.

### **Policy Statements**

- NZDA Canterbury will comply with all requirements of the Privacy Act 2020 and, where applicable, the Health Information Privacy Code 2020.
- Only necessary information will be collected from the person themselves.
- Only people whose roles directly relate to the information will have access to it.
- Information will be stored and disposed of with proper safeguards against loss or wrongful disclosure.
- Notifications to the Privacy Commissioner will follow the prescribed process outlined on the Privacy Commissioner's website.
- The Executives are to be notified immediately of any privacy breach.
- Affected individuals will be notified as soon as possible. If not reasonably practical to advise personally, notification will be made by public notice.

### **Privacy Statement - Members**

NZDA Canterbury collects personal information from Members, including names, dates of birth, contact details, dental education details, Dental Council registration details, employment details, information about complaints against them and invoicing information.

We collect this personal information in order to:

- Invoice members
- Confirm membership so we can provide support as required
- Provide links to regular publications and information
- Notify members branch events such as meetings

Contact information is only shared with NZDA Canterbury Executives, NZDA head office, and the Administrative assistant to the branch.

Members have the right to ask for a copy of any personal information we hold about them, and to ask for it to be corrected if they think it is wrong. Contact our Privacy Officer at admin@canterburydentists.org.nz to ask for a copy of information or have information corrected.

All information is kept secure for as long as required legally, and will be disposed of thereafter.
